in the Sum of *Two thousand* ~~Pounds~~ Pounds, lawful Money of *Pennsylvania* to be paid to the said *Jacob S. Cohen* his certain Attorney, Executors, Administrators or Assigns. To which Payment well and truly to be made, I do bind myself my Heirs, Executors and Administrators, and every of them firmly by these Presents. Sealed with my Seal Dated the *Twenty second* Day of *August* in the Year of our Lord One Thousand Seven Hundred and *Eighty four*

THE Condition of the above Obligation is such, That if the above-bounded *Haym Salomon* or also his Constituent the said *J. Jacob Abraham* their Heirs, Executors and Administrators, for ~~him~~ their Parts and Behalf, do in all Things well and truly stand to, obey, abide, perform, fulfil and keep the Award, Order, Arbitrement, final End and Determination of *Joseph Wolff Carpenter and Simon Nathan* both of the said City of Philadelphia Merchants

~~any~~ of ~~them~~, Arbitrators indifferently named, elected and chosen, as well on the Part and Behalf of the ~~above-named~~ *J. Jacob Abraham* as of the above-named *Jacob S. Cohen* to arbitrate, award, order, judge and determine the Claims & Demands of him the said *J. Jacob Abraham* of in & to the Real & Personal Estate of *Spheerim Abraham* late of the State Virginia Merchant deceased in the possession of him the said *Jacob S. Cohen*

and of and concerning all and all Manner of Action and Actions, Cause and Causes of Action and Actions, Suits, Bills, Bonds, Sum and Sums of Money, Trespasses, Accounts, Damages and Demands whatsoever at any Time or Times heretofore had, made, done, committed or depending, by or between the said *J. Jacob Abraham* and the said *Jacob S. Cohen* so as the said Award be made in Writing, indented under the Hands and Seals of the said Arbitrators, ~~any~~ of ~~them~~, and ready to be delivered to the said Parties in Difference, or such of them as shall require the same, on or before the *second* Day of *September* next ensuing the Day of the Date hereof. But if the said Arbitrators do not make such their Award of and concerning the Premises, by the Time aforesaid limited, That then if the said *Haym Salomon* or also the said *J. Jacob Abraham* their Heirs, Executors and Administrators for ~~him~~ their Parts and Behalfs, do in all Things well and truly stand to, obey, abide, perform, fulfil and keep the Award, Order, Arbitrement, Umpirage, final End and Determination of such Person as shall be named and chosen, by the said Arbitrators, for an Umpire between the said Parties, of and concerning the Premises, so as the said Umpire do make his Award or Umpirage in Writing, indented under his Hand and Seal, ready to be delivered to the said Parties in Difference, or such of them as shall require the same, on or before the *seventh* Day of *September* aforesaid, then the above Obligation to be void, or else to remain in full Force and Virtue.
